We still feel that these areas warrant greater attention, emphasis, and possibly resources, to influence other areas of activity and make the greatest impact overall.





#### Age Profile and % of Total Population




Barnsley's ethnic diversity continues to change. In the 2011 Census, 7 out of 100 people in Old Town were from a Black and Minority Ethnic (BME) group compared to 4 in every 100 people in Barnsley overall. The 2011 Census is the most up to date national data available on ethnicity.

### Demographics **Indices of Multiple Deprivation 2015**

This is calculated based on seven domains of deprivation, which in turn are composed of a number of indicators that are scored and ranked to produce an overall domain score.


#### Proportion of Old Town Lower Super Output Areas (LSOAs) in 10% Most Deprived in England

LSOAs in 10% Most Deprived in England LSOAs not in 10% Most Deprived in England




#### The Seven Domains of Deprivation and how Old Town Performs

**Index of Multiple Deprivation 2015 Old Town LSOAs Relative to England** (DCLG, 2015)







#### % of Pupils Achieving a Good Level of Development 2013 - 2018



#### % of Pupils Achieving the Expected Standard in the Phonics Screening Check at the End of Year 1 2015 - 2018






The percentage of pupils resident in the Old Town ward achieving the expected standard increased in 2018 with outcomes now above both the Barnsley and national averages.





The percentage of pupils achieving the expected standard in reading, writing and mathematics combined increased in 2018 with outcomes remaining above both the Barnsley and national averages.








#### % of Pupils with Special Educational Needs and Disabilities 2018

#### Life Expectancy at Birth











Life expectancy at birth for women in Old Town is the same as for women in Barnsley.

#### **Under 18's Conceptions**




#### Under 75 Mortality (rate per 100,000 population)



Old Town's under 75 cancer mortality rate (159.9 per 100,000) is higher than the Barnsley rate of 152.4. Rates have fluctuated during the period 2010-2012 to 2015-2017.




Old Town's under 75 mortality rates from respiratory diseases have been consistently lower than the overall rates for Barnsley at each time point during the period 2010-2012 through to 2015-17. However, the current rate of 39.1 is higher than it was in 2010-2012.




Under 75 mortality rates from cardiovascular diseases in Old Town have fluctuated during the period 2010-2012 to 2015-2017. The current rate of 87.5 per 100,000 is slightly higher than the Barnsley rate of 87.0.


#### **Excess weight**




The proportion of 10-11 year olds in Old Town who are overweight or obese (32.7%) is higher than the proportion in Barnsley overall (32.1%).




#### Smoking





Just under a quarter of adults in Old Town are smokers. The current rate of 23.7% is higher than the Barnsley


#### **Related Deaths per 100,000 (Over 35's)**




#### **Residents Living Alone and Aged 65+ Years**




The 2011 Census showed that 11.0% of households in Old Town contained residents aged 65+ years that were living alone and could be at risk of social isolation.



More than two thirds of properties are owned with a mortgage or owned outright in Old Town. Ownership is higher than both the Barnsley and England rates.




A total of 1 in 7 properties in Old Town are social rented; this is lower than both Barnsley and England.

Properties are banded into one of eight valuation bands (A to H, with A being properties of lowest value to H being the highest). These are decided by the government's Valuation Office which determines the amount of council tax to be paid. The chart shows that there are more Old Town households in Band B compared to Barnsley and England.



#### Total Crime (rate per 1,000 population)







#### Crime (rate per 1,000 population)








There has been a continual notable reduction in the rate of Anti Social Behaviour (ASB) in Barnsley, as changes in crime recording practices implemented by South Yorkshire Police in October 2016 have steadily reduced the number of ASB incidents. Offences that would have previously been recorded as ASB are now recorded as criminal offences where applicable.


The ASB rate for Old Town is higher than both the Barnsley and England rates.

**Barnsley Internet Speed** 









#### Access to a Car or Van


#### No Cars or Vans in Household

#### Mortality Rate from Causes Considered Preventable (rate per 100,000 population)






The mortality rate from causes considered preventable in Old Town is slightly higher than the rate for Barnsley.
