#### **Background:**

The issue is – How to promote consistency in the level of consultation and publicity in relation to those affected by the works.

#### Advice:

The "Consultation & Publicity Guide" was produced with the input of the members of YPOG and YPSB to provide guidance on the level of engagement required dependant upon:

- Works Type (Major, Standard, Minor and Immediate)
- Location and impact of the works (e.g. working at traffic sensitive times or not, traffic management requirements, walkway provision, etc.)
- Duration of the works in calendar days.

Levels of consultation and publicity were defined in Appendix A (L1 to L7, YI02, YI03) and suggested levels then applied in Appendices B to D to the differing Works Type scenarios based upon the duration of works (calendar days).

The Guide is not a prescriptive document as all works should be assessed individually, according to the work being undertaken at the time and the prevailing circumstances. The Guide and suggestions made should, however, be used as a planning tool when considering the level of engagement required.
