## Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

I am writing to request information under the Freedom of Information Act 2000 regarding your council's actions relating to non-compliant trading practices, particularly involving stores selling illegal tobacco and vaping products, between 2020 to the latest available date.

Specifically, I would like to request the following information:

-The number of stores that have been issued closure orders by your council during this period due to the sale of illegal tabacco and vaping products

2025 - 1

-The total number of vapes seized by your council's Trading Standards or other relevant teams during this period -The total estimated monetary value  $(\pounds)$  of the seized vapes

We do not record this in retrievable form via our database. In addition officers visiting stores for reasons other than vape enforcement work will where appropriate seize illegal vapes. In order to collate this information we would need to extract the information from a high number of report records across officers of the service. This would take the request outside the time constraints of a Freedom of Information request.

I would prefer to receive the requested information in electronic format, and if possible, broken down by year.
