Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

Specifically, I am asking for the following information:

- **According to the council's recorded information how many floating support services has the council either reduced funding for or stopped funding between 1st April 2023 and 31st March 2025?**
The council has not reduced or stopped funding any floating support services during this period. There has been a reduction in capacity within one floating support service to ensure the service remained financially viable, but the contract value and level of funding was unchanged.
- **According to the council's recorded information how much money has the council saved by reducing funding or stopping funding for floating support services between 1st April 2023 and 31st March 2025?**
The council has not reduced or withdrawn funding from any floating support service during this period, so has not made any financial savings from these services.
- **According to the council's recorded information how many homelessness services and supported housing services has the council either reduced funding for or stopped funding between 1st April 2023 and 31st March 2025?**
The council has not reduced or stopped funding any homelessness services or supported housing services during this period.
- **According to the council's recorded information how much money has the council saved by reducing funding or stopping funding for homelessness and supported housing services between 1st April 2023 and 31st March 2025?**
The council has not reduced or withdrawn funding from any homelessness or supported housing services during this period, so has not made any financial savings from these services.
