FEES NOT SET BY THE COUNCIL

Permits

Local Authorities already issue a number of permits or registrations for activities under existing legislation. Under the Gambling Act 2005, the Licensing Authority will be responsible for dealing with following permits and registrations;

- Unlicensed Family Entertainment Centre Gaming Machine Permits
- Registration of small lottery licences
- Club Gaming Permits
- Club Gaming Machine Permits
- Licensed Premises Gaming machine Permits
- Prize Gaming Permits

Unlike premises licence fees, permit fees are set by the Government and the Council has no discretion to set these fees. At this time the only permit fees which have been set are for Family Entertainment Centre Gaming Machines and Prize Gaming which are summarised below;
