**1. Questions from Parishioners**

A local resident asked what are the Parish Councillors plans to alleviate problems in the Village with regard to floods. He had not received a response from Barnsley MBC in relation to his request for a road sweeper, and the silt and leaves from the fields regularly block the drains between the village stone and the bench. The footpath is in a disgraceful state and needs sweeping. The drain near the turning circle also gets blocked on a regular basis. Additionally the drain opposite the Golf Club spews water out like a fountain when there is heavy rainfall and is clearly not working properly. A discussion followed and it was agreed that the Clerk would report the residents' concerns through to Barnsley MBC.

It was noted that the litter at the turning circle was really bad.

It was noted that a small touring caravan had appeared on some grazing land in the village. One of the Councillor has reported this through to the Planning Department as the development of grazing land is unlawful.

The Parish Councillors noted that Barnsley MBC has miscalculated the amount of fly tipping in the Borough which had actually increased year on year by 20%.
