**Re: Request for Information – Freedom of Information Act 2000**

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

**Under the Freedom of Information Act 2000, I request the following information for the previous 6 months.**

**I recognise that some driving undertaken without a tachograph card may be legitimately exempt (for example, domestic driving correctly recorded manually in drivers' hours records). This request is intended to distinguish such lawful recording from instances where a tachograph card was required but not used.**

**Please provide, in aggregated form:**

**1. The total mileage (in miles) recorded as driven in vehicles subject to tachograph regulations where no driver tachograph card was inserted, excluding mileage that was subsequently identified as lawfully recorded as domestic driving in drivers' hours books or equivalent manual records.**

**2. The number of incidents identified during this period where driving without a tachograph card was considered non-compliant.**

**3. A monthly breakdown of the information requested in points 1 and 2.**
