Minimum distance between any two temporary traffic signals to be 30m.</div><div>3 Temporary traffic signals shall not occur within 150m of an existing level crossing. Pelican crossing or signalised junction without the consent of the Engineer. The Engineer shall consult with the authority responsible for any of these types of facility prior to traffic management being installed in adjacent areas.</div><div>4 Coning shall be installed at 45° to the edge of carriageway, as generally indicated.</div></div>
