I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

Dear Information Requests Team, Thank you for your response to FOI 4880 regarding "pool cars." Whilst you have confirmed that Barnsley Council does not operate any scheme explicitly under that label, I would like clarification on whether the same type of arrangement exists under different terminology. Please provide, for the period 1 January 2020 – present:

1. A list of all suppliers used for vehicle hire, car hire, van hire, contract hire, fleet hire or car-club/shared-use vehicle services (e.g. Arrow Self Drive, Northgate Vehicle Hire, Enterprise Flex-E-Rent, Lex Autolease, LeasePlan, Arval, etc.), including total spend by financial year.
