Barnsley Metropolitan Borough Council comments on Silkstone Neighbourhood Development Regulation 16 Consultation

Barnsley Council would like to congratulate Silkstone Parish Council on the quality of the work done on the production of the Silkstone Neighbourhood Development Plan.

Barnsley Council would also like to record thanks for the co-operative approach which Silkstone Parish Council has taken to working with officers from Barnsley Council.

Since Barnsley Council comments on the regulation 14 consultation have been pretty fully taken into account there are only a couple of detailed comments on the draft Neighbourhood Plan, as follows:

- 1. Policy LGS1 Local Green Spaces states 'Inappropriate development of Local Green Space is ruled out other than in very special circumstances'. It is clear that this is reflecting the requirement in NPPF para 103 that 'Policies for managing development within a Local Green Space should be consistent with those for Green Belts'. However, there is nothing in the policy as drafted that explains what inappropriate development is. In addition, it is not clear that 'appropriate development' would be acceptable on local green space if it would cause harm to the particular local significance that justified the local green space designation. It is recommended that the policy could be better worded 'Development will not be permitted within a Local Green Space unless there are very special circumstances which outweigh the harm to the Local Green Space including the loss of the particular local significance that justified the designation'.
- 2. Policy RD1 Supporting Rural Diversification and Tourism has been amended to include the qualification that support for Airbnb is not where it would comprise the loss of existing larger dwellings. It is suggested that the policy or text is amended to clarify that existing larger dwellings are considered to be 4+ beds, reflecting Barnsley Council's proposed amendments to the adopted SPD Design of Housing Development (consultation on these and other amendments closed on 31 October).
- 3. Barnsley Council will share the Parish Council's regret that the Design Code as originally prepared was not able to be made accessible for publication on the Barnsley Council website, and that the revised version lacks the photos and illustrations that accompanied and illustrated the words.



National Grid is able to provide advice and guidance to the Council concerning their networks and encourages high quality and well-planned development in the vicinity of its assets.

#### **Electricity assets**

Developers of sites crossed or in close proximity to National Grid assets should be aware that it is National Grid policy to retain existing overhead lines in-situ, though it recognises that there may be exceptional circumstances that would justify the request where, for example, the proposal is of regional or national importance.

National Grid's 'Guidelines for Development near pylons and high voltage overhead power lines' promote the successful development of sites crossed by existing overhead lines and the creation of well-designed places. The guidelines demonstrate that a creative design approach can minimise the impact of overhead lines whilst promoting a quality environment. The statutory safety clearances between overhead lines, the ground, and built structures must not be infringed. Where changes are proposed to ground levels beneath an existing line then it is important that changes in ground levels do not result in safety clearances being infringed. National Grid can, on request, provide to developers detailed line profile drawings that detail the height of conductors, above ordnance datum, at a specific site.

#### Gas assets

High-Pressure Gas Pipelines form an essential part of the national gas transmission system and National Grid's approach is always to seek to leave their existing transmission pipelines in situ. Contact should be made with the Health and Safety Executive (HSE) in respect of sites affected by High-Pressure Gas Pipelines.

National Grid have land rights for each asset which prevents the erection of permanent/ temporary buildings, or structures, changes to existing ground levels, storage of materials etc. Additionally, written permission will be required before any works commence within the National Grid's 12.2m building proximity distance, and a deed of consent is required for any crossing of the easement.



# Re: THE SILKSTONE NEIGHBOURHOOD DEVELOPMENT PLAN UNDER REGULATION 16 OF THE NEIGHBOURHOOD PLANNING (GENERAL) REGULATIONS 2012

Thank you for your notification received on the 10<sup>th</sup> October 2022 in respect of the above consultation.

The Coal Authority is a non-departmental public body sponsored by the Department of Business, Energy & Industrial Strategy. As a statutory consultee, The Coal Authority has a duty to respond to planning applications and development plans in order to protect the public and the environment in mining areas.

Our records indicate that within the identified Neighbourhood Plan area there are recorded coal mining features present at surface and shallow depth including: mine entries, shallow coal workings, and surface coal extraction reported surface hazards. These features pose a potential risk to surface stability and public safety.

The Coal Authority's records also indicate that surface coal resource is present in the area, although this should not be taken to imply that mineral extraction would be economically viable, technically feasible or environmentally acceptable. As you will be aware those authorities with responsibility for minerals planning and safeguarding will have identified where they consider minerals of national importance are present in your area and related policy considerations. As part of the planning process consideration should be given to such advice in respect of the indicated surface coal resource.

Following a review of the document, it does not appear that the Neighbourhood Plan, as proposed, allocates any sites for future development and on this basis the Planning team at the Coal Authority have **no specific comments** to make on this document. However, if the Neighbourhood Plan does propose to allocate sites for future development, consideration will need to be given to the potential risks posed to surface stability by past coal mining activity.
