I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

1. The total number of Penalty Charge Notices (PCNs) issued for parking violations for the last 5 years 2020 - 2025(current)

2019/20 – 11,276 issued
2020/21 – 3,788 issued
2021/22 – 4,606 issued
2022/23 – 7,596 issued
2023/24 – 7,014 issued
2024/25 – 8,790 issued.
2025/26 – 5,553 issued.

2. The total revenue collected from parking PCNs in each of the above years

2019/20 - £297,592
2020/21 - £137,973
2021/22 - £135,617
2022/23 - £192,839
2023/24 - £215,806
2024/25 - £265,244
2025/26 - £112,275

3. The number of PCN appeals received and the number successful in each year
