Minutes of the Council Meeting held on 14th April 2016
At Hood Green Pavilion commencing 7.00 p.m.

1243. To receive disclosures from Councillors on matters to be considered at the meeting: No disclosures of personal and prejudicial interests were declared

1244. To approve the minutes of the Council Meeting held on 25th February 2016: The minutes of the meeting held on 25th February 2016, having been previously circulated, were approved as a true record.

1245. Matters arising:

a. Pavilion – Refurbishment: New keys have been provided for Sam Lockwood Dukes and Karen the cleaner.

Brian Moss has obtained and fitted the replacement of the water heater.

Brian Moss to take photographs of the damage and send initial application to War Memorials Trust for grant to refurbish War Memorial.

Prices to be obtained for Redecoration of Pavilion (Brian Moss), Curtains (Dot Winder) and new floor covering.

Brian Moss will write to both Art Group and Knit, Stich & Natter asking them to clear the pavilion of all of their equipment before redecorations can start.

b. Safety at Stainborough Crossroads: Kelvin Taylor has been advised that there are alternative Speed Indicators which may be considerably cheaper than the indicative price we received from BMBC. Kelvin will investigate the alternatives which may be more suitable for our needs.

c. Dog Fouling: Further details are still needed for pricing of rigid signs are needed but they will be approximately £25-£30. A review of the location of the signs is needed following the next Playground Inspection.

d. Village Planters: Dot Winder has obtained volunteers for planting and maintenance of village planters. Kelvin Taylor will obtain compost from Allotment Society at an advantageous price. Dot Winder will obtain the plants in conjunction with Carol Whitton.

Brian Moss has approached John Openshaw and met with Elaine Downs who controls the Councils Green and Clean Team. They have agreed to cut back the brambles at the top of the recreation ground but cannot cut the overgrown hedges around the Pavilion until the end of the nesting season.
