Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

I am writing to request information under the Freedom of Information Act 2000 regarding your council's expenditure on temporary staffing or employment agency services. Specifically, please provide:

Total amount paid to Reed Specialist Recruitment Ltd in each financial year from 1 April 2022 to 31 March 2025 (i.e. FY 2022-23, 2023-24, 2024-25).

2022-23 £6.414M 2023-24 £11.134M 2024/25 £9.695M

Aggregate total paid to all staffing/employment agencies in the same financial years (i.e. combined across all agency suppliers).

2022-23 £7.338M 2023-24 £12.791M 2024/25 £10.227M

It is worth noting that agency staff are in the main used to fill vacant permanent positions that are difficult to recruit to – e.g social workers given national shortage etc. As such the Council underspent in its permanent staffing budgets in each of the three years which was used to offset the costs highlighted above

2022-23 total net saving of £9.521M after agency costs above 2023-24 total net saving of £6.446M after agency costs above 2024/25 total net saving of £11.251M after agency costs above
