Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

- How many public toilets are currently open in your council area and how many of these are accessible? 132 toilets. It is difficult to confirm number of accessible toilets, but average is 15% of total number
- How many public toilets have been open for each of the years 2020, 2021, 2022, 2023 and 2024 and how many have been accessible? –

2020 - 100

2021 - 114

2022 - 114

2023 - 114

2024 – 132 *increase is due to purchase of Alhambra Centre

As stated above, it is difficult to confirm number of accessible toilets, but average is 15% of total number

- How much is currently being spent on providing and maintaining public toilets in your council area and how much has been spent for each of the years 2020, 2021, 2022, 2023 and 2024? There is no specific allocated budget for providing or maintaining public toilets
- How many of the public toilets available require the public to pay to access them, how much do they charge, for this year and each of the years 2020, 2021, 2022, 2023 and 2024? none
