Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

Under the Freedom of Information Act 2000, I am requesting the following recorded information regarding full fibre (FTTP) deployment in Wombwell, Barnsley:

- 1. The date on which property 10 Princess Gardens, Wombwell, Barnsley, S73 0ED is scheduled to be released as "order ready" for FTTP services.
- 2. The date on which properties on Kingsway, Wombwell, Barnsley, S73 0EB were released as "order ready" for FTTP.
- 3. The date on which properties on Queens Gardens, Wombwell, Barnsley, S73 0EE were released as "order ready" for FTTP.
- 4. Any internal documentation, rollout schedules, or project records that explain why Princess Gardens (S73 0ED) has not yet been enabled, despite adjacent streets being completed.
- 5. Any planned or scheduled works within the next 12 months that relate specifically to enabling Princess Gardens (S73 0ED) for FTTP order availability.

Thank you for your Freedom of Information request regarding the full fibre (FTTP) deployment in Wombwell, Barnsley.

After reviewing your request, we believe you are seeking information relating to Openreach's full fibre rollout. Please note that this is a commercial endeavour managed by Openreach, and as such, Barnsley Metropolitan Borough Council does not hold the specific information you have requested regarding rollout schedules, order availability dates, or any internal project records for these works.
