**I would like any copies of traffic data that are relevant to traffic flows on the B6132 at Royston, specifically traffic that is flowing across the border into West Yorkshire. I would consider any data that you have on Station Road or Summer Lane in Royston, or on Bleakley Lane itself just north of them.**

**If possible I would like the raw data as well as any processed data that you may have.**
