Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

1. Perpetrator Service Provision

 What services or programmes are currently available for perpetrators of domestic abuse in your area?

The primary service available for perpetrators of domestic abuse in Barnsley is a programme called Inspire to Change. This is delivered across South Yorkshire via a partnership contract with the 4 local Authorities and South Yorkshire Mayoral Authority. It is a structured 24-week behaviour change programme for individuals aged 16 and over. These are delivered predominantly in person at group sessions with one to one sessions and online support if necessary.

A complementary programme, Level Up, is available for younger individuals aged 11–15 this is a 12-week programme only delivered in Barnsley. These sessions are one to one delivered in person by Cranstoun.

2. Access Pathway

How can individuals access these services (e.g. self-referral, professional referral)?

Professional referrals are preferred to ensure that the right level of support is offered. These come from a range of agencies and services including Police, Children's Social Care, Family Courts, Victim/Survivor Support Services, Probation, Housing, Education and Healthcare providers.

The referral process requires active consent and includes a comprehensive assessment of behavioural readiness, risk level, and individual needs (e.g. neurodiversity, mental health, housing). It also encourages victim engagement to ensure support and safeguarding.

A self-referral pathway is also offered.

o Is there a referral form or online portal?

Information and referral details are available from several online sources including the Barnsley Council and Live Well Barnsley websites. The Cranstoun website also includes sections for Inspire to Change and Level Up. There is no online portal at this time, but an improved digital offer forms part of the specification of the new commission of Inspire to Change which will start in April 2026.

3. Eligibility Criteria

Are there specific criteria for accessing these services (e.g. risk level, residency, relationship status)?

Inspire to Change is available to anyone over 16 living in South Yorkshire and Level Up is available to individuals aged 11–15 living in Barnsley. Eligibility to both is determined through a structured assessment process that considers:

- Behaviour towards a partner or family member.
- Motivation and commitment to change
- Primary perpetrator status (main aggressor where there are counter-allegations)
- Risk level
- Specific needs, including neurodiversity, disability, substance misuse, and mental health.

The programme is inclusive and offers tailored interventions for diverse groups, including those whose first language is not English.

Monitoring includes a quarterly narrative report and KPI measurement this includes details on engagement and outcomes. Data included in these reports:

- Referrals Paths
- Risk levels
- Non Engagements rates

- Reasons for Early exits
- Complaints/Compliments
- Victim/Survivor evaluation
- South Yorkshire Police Reoffending data (where perpetrator is known to police. Not quarterly)

Reports and evaluations that are not already in the public domain are not currently available. Inspire to Change programme is currently subject to a live tendering process.
