The information requested and our findings are as follows: -

Dear Sir or Madam Under the Freedom of Information Act, I would like to request the following information: Have you in the past or, do you currently, allow as eligible for Housing Benefit or Universal Credit the "OKEachDay" service provided by: Alertacall Ltd 45 Crescent Road Windermere LA23 1BL The OKEachDay service requires that a tenant/resident presses a button each day before an agreed time to check that the tenant/resident is okay. If you do allow OKEachDay, can you tell me the date of that decision and why? If you do not allow OKEachDay, can you tell me the date of that decision and why?

We do not currently have any Housing Benefit claims with the service charge "OKEachDay". Housing Proactive, provided by Alertacall, has been identified as an eligible service charge, however because OKEachDay is an optional feature, any charges for this feature would not be eligible due to being optional or for personal use.
