Decisions on CPOs would be taken by the Council's Cabinet. As these meetings are held in public, all reports related to CPOs will have already been published alongside the record of the decision and are available on the council website here: [Browse meetings - Cabinet](#)

Where these reports contain information exempt under the Local Government Act Schedule 12a, this information may have been withheld at the time of consideration due to this being in the public interest. For some reports it may now be possible to release the information, however this would be considered on a case-by-case basis by the Monitoring Officer.
