PUBLIC PATH DIVERSION ORDER 2025**

THIS ORDER is made by Barnsley Metropolitan Borough Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner and occupier of the land crossed by the footpath described in paragraph 1 of this Order and the public it is expedient that the line of the footpath should be diverted.

**BY THIS ORDER:-**

1. The public right of way over the land situate alongside Bell Royd Farm, Thurlstone and shown by bold continuous lines on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order.
2. There shall at the end of 28 days from the date of confirmation of this Order be another public right of way over other land situate to the south east of Bell Royd Farm, Thurlstone aforesaid described in Part 2 of the Schedule and shown by broken lines on the map contained in this Order.
3. This Order may be cited as the Metropolitan Borough of Barnsley (Public Footpath No. 54 Penistone) Public Path Diversion Order 2025.

**THE SCHEDULE**

**Part 1**

**Description of Existing Footpath**

The full width of a section of Penistone Public Footpath no. 54 which commences at a point 337 metres north east of its junction with Folly Lane, Thurlstone grid reference SE 2286 / 0485 (Point A on the order plan) and proceeds north east for a distance of 77 metres to grid reference SE 2291 / 0491 (Point D on the order plan) then proceeds south east for a distance of 11 metres to grid reference SE 2292 / 0490 (Point C on the order plan).

**Part 2**

**Descriptions of New Footpath**

A public footpath having a width of 2 metres throughout which commences at a point 337m north east of its junction with Folly Lane, Thurlstone grid reference SE 2286 / 0485 (Point A on the order plan) and proceeds south east for a distance of

6 metres to grid reference SE 2287 / 0484 (Point B on the order plan) then north east for a distance of 80 metres to grid reference SE 2292 / 0490 (Point C on the order plan).

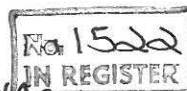

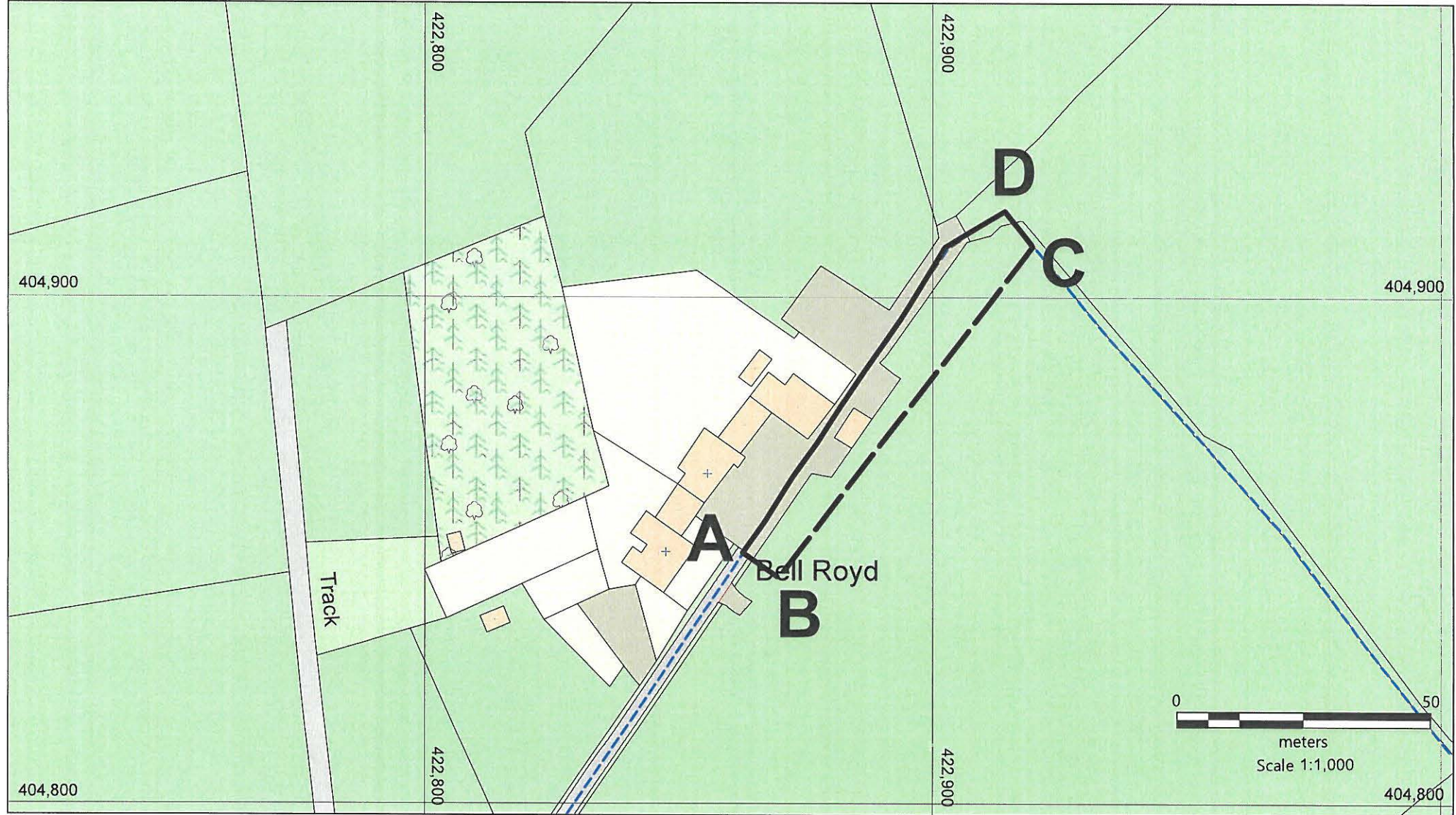
