### Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

Please provide detailed information in relation to missed bin collections in the Barnsley Metropolitan Borough Council service area, particularly for Worsbrough.

Since January 2025 we have had missed bin waste collections every month. There has not been a month without one bin or another not being emptied.

The missed waste collections frequently extend beyond one week post scheduled collection day. Currently our brown bins are nearly two weeks overdue and we have been advised today that it will be another two weeks before these bins are emptied. I hear reports of one area of Barnsley where the black bins have not been emptied for almost two months.

I and other residents need to know why our bins are not being emptied on time.

To help us understand the issues, provide us with the following details:

## 1. The number of failed collections;

A late collection is defined as a collection that is not made on the scheduled day published in the collection calendar.

# 2. The average length of time for bins to be emptied after a failed waste collection;

Waste Services strives to return for missed collections as soon as resources allow, excluding individually reported missed collections. Currently, there is no service level agreement specifying the timeframe within which we are required to return for collection. As a result, while we monitor the properties awaiting collection, we do not record the number of days between their scheduled collection date and the actual collection date.

### 3. The causes behind missed bin waste collections;

During January, we experienced a period of severe weather that significantly affected waste collections. The snowfall disrupted services on the day it occurred, while the subsequent days of sub-zero temperatures further hindered collections and our efforts to resume the scheduled service.

Other reasons for missed collections include vehicle breakdowns, staff illness, delays at transfer stations, road closures, and inaccessible streets due to parked cars, among other factors.

4. A breakdown of the number of staff working in refuse collection and management per each official job role for the years 2025, 2024, 2023, 2021, 2020 and 2019 so we can determine whether there is a staffing issue;

# 5. Information related to whether the Barnsley refuse collections staff and refuse management staff or the equipment are being used outside of the borough;

All Barnsley refuse collection staff, refuse management personnel, and equipment are exclusively deployed within the borough. There are no instances where our staff or resources are allocated for operations outside of Barnsley.
