

Introduction

In the Summer of 2023, we asked for views on updates to the Financial Contributions to Schools Supplementary Planning Document (SPD). You can read a summary of the comments made in summer 2023 on our website at https://www.barnsley.gov.uk/services/planning-and-buildings/supplementary-planning-documents/

Following this initial consultation, we proposed further changes to the SPD to take account of comments made. Given the changes were significant, we consulted on the draft document again. The comments made on those further changes are summarised below.

Public consultation took place on the further updated Financial Contributions to Educational Provision Supplementary Planning Document for a period of four weeks between Tuesday 10 September to Tuesday 8 October 2024. A total of 2 specific comments were received from 6 respondents.
