Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

Please could you provide details in the last year so June 2025 to current for Farrow Close Dodworth of how many time the green bin was missed on the scheduled Tuesday collection day There should be records to show this.

Please find below a table showing the green bin collection history for Farrow Close, Dodworth. The data has been extracted from our in-cab system, which was introduced last year. Green bin collection crews began using this system in July 2025; therefore, the information provided covers the period from July 2025 onwards rather than from June, as originally requested.

Please note that, although the data indicates a number of collections were not completed on their scheduled collection date, all missed collections were returned to and collected within 48 hours of the original scheduled collection date.
