Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

Please may you provide me with: the latest information held on graffiti cleaning and budgets/spending in Barnsley Metropolitan Borough Council for the past 2 years 2025, and budgeted for 2026 (or the most recently available data for a 2 year period).

Information should include,

1) Total number of graffiti instances reported in 2025

The total number of graffiti instances reported in 2025 were 961.

2) Total number of graffiti instances resolved in 2025, e.g. cleaned/removed

The total number of graffiti instances resolved in 2025 was 939.

3) Total council spending on graffiti removal/cleaning in 2025 (if the exact spend isn't available, how much was budgeted?)

The total spent on graffiti removal/cleaning in 2025 was £91048.00

4) Total council budget for graffiti removal/cleaning in 2026

The total council budget for graffiti removal/cleaning in 2026 is approximately £95k.

5) Estimated typical response time for Council to remove/clean graffiti after it is reported

Estimated typical response time for Council to remove/clean graffiti after it is reported is within 24 hours for offensive graffiti, and within 28 days for non-offensive graffiti.
