Older people (65+)

The above rates reflect the rates paid to providers on our residential care framework for older people.

We do not pay an enhancement for nursing care, therefore the rates for Nursing care are the same as above with FNC added.

Working age adults (18-64)

Year	Residential - Lowest	Average
2024/2025	751.56	2648.26
2025/2026	806.42	2841.58

For working age adults fees are agreed case by case based on the needs of the individual, as such we do not have a separate rate for EMI.

The figures provided above reflect the lowest rates paid for a WAA residential placement in that financial year exclusive of FNC however we have also included the average as most WAA fees are above standard rates paid.
