## Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

Your questions and my findings are as follows:-

- 1. In the last full financial year for which records are available (or the period April 2024 April 2025 if this is more readily available), did the local authority provide any evidence-based parenting groups in non-English languages?
- Non-English languages refers to spoken and sign languages (please note that the parenting group delivered in the non-English language should be about parenting, not language tuition or programmes for deaf individuals unless specifically about parenting).
- -This includes groups delivered face-to-face or via virtual platforms but does not include online websites, online courses parents complete independently, or individual appointments between 1 family and 1 practitioner.
- 'Parenting groups' refers to any online or in-person group set up to deliver a set programme or curriculum to parents, offering parenting support of any nature, such as incredible years, nurture, or Triple P (or any similar group). These groups would typically be led by child development professionals, nurses, health visitors or similar qualified persons. It doesn't include toddler groups, coffee mornings or similar.
- I am interested in parenting groups for families of children of any age, from antenatal support up to support for parents of teenagers.
- I am only interested in parenting groups not 1:1 support, such as early help appointments or individual support in general. Therefore, practitioners who have used interpreters on an individualised basis separate to parenting group provisions, are not of interest to me. However, I am interested in 1:1 support if it was facilitated on a special basis as an <a href="extension/adjustment of a parenting group">extension/adjustment of a parenting group</a> due to the non-English speaking parent requiring <a href="extension/adjustment-of-a-parenting-action-decomposition-deco
