Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

I would like to request the following information under the Freedom of Information Act 2000/Freedom of Information (Scotland) Act 2002 (as appropriate):

- **How much is the full, undiscounted penalty for a bus gate breach in your authority (i.e. Driving an unpermitted vehicle through a bus gate)?**
£70.00 reduced to £35.00 for payment within 21 days of issue of the PCN.
- **How many bus gates and bus lanes do you operate in your authority?**
9 in total.
 - **Please break these down into separate counts of bus lanes and bus gates.**
9 bus lanes, 7 bus gates.
 - **If, for cost reasons, it would prove too expensive to provide counts for both, please only provide counts for bus gates.**
- **For the year 2024, please provide the number of bus gate breaches recorded in your authority.**
We currently do not enforce bus lanes.
 - **For clarity, I am requesting only bus gate breaches rather than bus lane breaches.**
 - **If this is not possible, please provide the total number of bus lane and gate breaches recorded in the year 2024.**
