A list of all properties and land disposed of by the council between 1 January 2020 and 31st October 2025. For each disposal, please include:

The address/location of the land/buildings The date of disposal The method of disposal (e.g., sale, transfer) Whether the asset was sold with planning conditions attached Whether the disposal was conducted in line with a policy objective, and if so, which one The price or value achieved including nil value and/or any payments made by the council.

Whether the disposal was made at 'less than best' consideration

I would prefer to receive this information in an electronic format, ideally as a spreadsheet attached to an email.

Please contact me if you require any clarification regarding my request.

If you are unable to provide all of the requested information, please provide as much as possible and explain the reasons for any omissions or exemptions applied.

Please find a list of all properties and land disposed of by the Council between 1 January 2020 and 31 October 2025 as requested and presented in a spreadsheet format.

The list has been split into each financial year and provides details of each asset's UPRN, Address/Description, Date of Sale, Sale Amount and Reason for the Sale. The remaining information that you have requested is not held within the Council's asset register database system and therefore cannot be provided in the spreadsheet.
