I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

- e. The total estimated contract value at the point of signing. £100M
- f. The current total value to date (cumulative spend) and any revised valuations since 2005 £64,029,181.95 as at July 2025
