Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

Can you please advise what funding has been allocated to the North East Ward from the above. I understand there is or was £25,000 allocated to each Ward, to be used only by the community groups etc. This money has been used solely for their projects to enhance their communities.

What community groups etc have applied for this funding and for what project or projects to enhance their areas within the North East Ward of Shafton, Brierley, Grimethorpe and Great Houghton.

The North-East ward was allocated £25k capital funding through the Love Where you Live programme to deliver a high-level local improvement capital project. The project was agreed through the Ward Alliance to ensure community ownership and involvement. The funding was not allocated as a grant that could be applied for by community groups. The capital project that has been agreed in the North-East ward is to celebrate the mining history embedded in Grimethorpe.
