**Re: Request for Information – Freedom of Information Act 2000**

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

**How much money does the council spend per annum on public liability for art installations within the borough.**

The Council does not hold a separate public liability insurance policy, specifically for art installations. Public liability insurance is purchased on a corporate basis and covers all Council activities and assets collectively, including public art. As such, it is not possible to identify or calculate an annual public liability cost attributable solely to art installations.
