The council does not hold information regarding how many hours per week a councillor would spend with a particular group/meeting. All roles are voluntary and unpaid. All elected members receive an allowance which is unrelated to the number of hours worked or number of outside bodies they sit on of £12,237 per annum. There are certain Special Responsibilities Allowances that are paid for members who hold certain roles of which Deputy Leader is one.
