I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

This includes all costs related to fulfilling Equality Act 2010 duties, such as dedicated programs, training, and embedded activities. The purpose is public interest transparency on resource allocation and value for money from council tax-funded spending.
