Dear Requester,

Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

Please provide the following information covering the past five years (from 2019 to 2024), or for as many years within that period as records are available:

1. Number of Buildings

- The number of council-owned or managed buildings where bird netting is installed (please include current and, if known, past installations within the five-year period).

We have 5 sites with bird netting installed.

2. Bird Deaths and Entanglements

- The number of dead birds found in bird netting each year.

- The number of birds found trapped or entangled in bird netting each year, broken down by species if recorded.

- Of those found trapped, how many were found dead and how many were rescued alive.

- For any birds found alive, please state what happened to them (e.g., released on site, taken to a vet, taken to a wildlife rescue, handed to a pest control contractor, or culled).

BMBC does not hold this data and all pest control relating to netting of birds is contracted to a third-party company.

3. Monitoring and Maintenance

- **How often the bird netting is inspected.** – Monthly, we also ensure that any issues, damages are reported so that repairs can be carried out.

- **How often the netting is repaired or replaced.** – We have monthly building inspections. Any damages are reported for a repair/replacement to be undertaken.

- **How many reports the council receives each year of trapped birds in its netting.**

- **How often the council checks that bird netting is not causing harm to birds and that it remains in good repair.** - Monthly Inspections carried out.

4. Rationale and Alternatives

- **The reasons the council uses bird netting on its buildings.**

Bird netting is used on buildings to prevent birds from accessing areas where they might nest or roost. The netting acts as a physical barrier and reduces health risks by keeping birds away from droppings and diseases, keeps areas clean, and protects BMBC sites from bird-related damage.

- Whether alternatives to bird netting were considered before installation (and if so, what alternatives were assessed). No other options considered.

5. Financial Information

- The total amount spent by the council on bird netting installation, maintenance, and repair for each of the past five years. - £11,000 has been spent on repairs and installation over the last 3 years
