Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

Your questions and my findings are as follows:-

1. The number of reports received by your Trading Standards office in the past 12 months regarding sellers who have taken payment for goods but failed to deliver them and have also refused to issue a refund or respond appropriately

The council does not hold this information in an easily retrievable format. In the 12 months from 12 May 2024, the service received 2,226 requests related to concerns about goods and services. Each record would require a manual review, with an average processing time of 10 minutes per request to ascertain the details you require.

Given that this would exceed the cost limit of 18 hours (£450) to complete, we are unable to fulfil your request under Section 12(1) of the Freedom of Information Act 2000.

2. The reported total or estimated value of the undelivered items in these cases

We do not hold this data.
