The information requested and our findings are as follows: -

Can you please provide the reasoning behind the moving of the sign on the boundary for Grimethorpe, which was originally next to the Willowgarth High School.


Who requested this to be done and how much did it cost?

A legal map showing the actual boundary of Grimethorpe and surrounding villages, which would reinforce any request to have it moved if it was proven to be incorrect.

The relocation was requested by Cllr Ashley Peace following redevelopment of Willowgarth High School. The sign needed to be moved due to the redevelopment works so the logical place to locate it was back-to-back with the existing sign for Brierley.

The relocation was requested by Cllr Ashley Peace in 2022, the cost of relocating the sign was £300.00.

We do not hold a 'legal' map of the boundary. Google Maps shows the boundary between Grimethorpe and Brierley as follows, the sign is located close to the boundary line (shown in red):
