Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

I would like to request some information from you under the Freedom of Information Act Data concerning the use of fixed penalty and penalty charge notices in your area.

I would like this information broken down by month from the latest available data stretching back to January 2022.

I would like the data laid out in a CSV and split up into the categories of FPNs i.e the specific number of FPNs handed out for littering, fly-tipping, dog fouling, fly posting and graffiti.

File attached. We only have this data broken down into years. We do not have a complete picture for 2025 so we have only provided until the end of December 2024.

I would also like to get the numbers of civil enforcement officers and ASB enforcement officers employed by the council for each month over the same period.

As discussed with the information team, Civil Enforcement implies Parking. So this will need to be clarified. For ASB enforcement: We have 44 Officers whose role involves dealing with ASB, however none of those have roles that solely deal with ASB.

If the data exists, I would also like to know how many of these officers get assigned to street patrols per month.
