Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

Your questions and my findings are as follows:-

1. The formula used to calculate the increase that factored in the National Insurance Contributions (NICS).

The Council does not use a set formula to calculate fee uplifts. Consideration is given to a number of factors including changes to the national living wage, inflation, current care market profile and the total resources available to the council to fund all ongoing cost pressures which includes any agreed increases in fees.

2. The percentage of council tax allocated towards social care. Did the council apply the maximum threshold allowed for this allocation? If not, could you please provide the reason for not doing so?

A 2% Adult Social Care Council Tax Precept was agreed in 25/26 – the maximum allowed – The additional funding received from this increase has been allocated directly to the increased costs of Adult Social care.

The total council tax increase for 25/26 was 4.9% (the maximum allowed without a referendum being 5%).

3. The current reserves held by the council.

Total reserves as at 31st March 2024 held by the Council was £219 million, the majority of which is committed against specific projects etc. The balance as at 31st March 2025 is yet to be finalised.
