1. How many domestic bin household waste collections were missed on the due date for collection between 2nd January 2025 and 5th April 2025?

^{*} Definition of a Late Collection:

A late collection is defined as a collection that is not made on the scheduled day published in the collection calendar.

2. How many domestic household waste collections were collected during this time?

Please see table above for the number of collections.

3. How many were collected within 7 days of their due date?

Waste Services strives to return for missed collections as soon as resources allow, excluding individually reported missed collections. Currently, there is no service level agreement specifying the timeframe within which we are required to return for collection. As a result, while we monitor the properties awaiting collection, we do not record the number of days between their scheduled collection date and the actual collection date.

4. How many were collected within 14 days of their due date?
