I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

The requested data is not available for the above years separately as records are continually being updated. Currently, there are 196 registered HMO's in Barnsley borough. Work is ongoing to identify and inspect those HMO's that are considered 'exempt' (not required to be registered; sometimes referred to as small HMO's) to which 454 have been identified so far.
