Re: Request for Information – Freedom of Information Act 2000

I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

Please provide the most recent data available (as of January 2025) regarding children and young people with a maintained Education, Health and Care Plan (EHCP) who are currently not on the roll of a registered educational setting or are awaiting a named placement.

44 children and young people are awaiting a placement. All children and young people awaiting a school placement are provided with an interim education offer.

Specifically, please provide a breakdown of these children by National Curriculum Year Group (e.g., Early Years/Nursery, Reception, Year 1, Year 2... up to Post-16).

Please see attached.

Please categorize the data into the following two groups:

1. Children Awaiting Provision:

Children with an EHCP where the named educational placement is yet to be finalized, or where the child is currently out of school awaiting a start date at a named setting.

2. Education Other Than at School (EOTAS):

Children with an EHCP who are currently receiving an EOTAS package (under Section 61 of the Children and Families Act 2014) because no suitable school place is available.

EOTAS is recorded separately to awaiting provision. At the beginning of January 2026 there were an additional 25 cases recorded as EOTAS.
