I wish to confirm that the council has completed its search for the information which you requested.

The information requested and our findings are as follows: -

Please provide data for each of the past three financial years, from 2022–2023 to 2024–2025.

For children and young people aged 0-25 who are resident in your local authority area, please provide the following information broken down by financial year:

- 1. The number of children with an Education, Health and Care Plan (EHCP) – data is number of plans maintained as at 31st March each financial year.**
